Process control technology for refinery upgrading – Bilfinger establishes foothold in Iran

Now that most of the economic sanctions against Iran have been lifted, the country has become an interesting partner for German industry. Bilfinger has now secured its first order there: one of Iran's largest refineries is being upgraded and Bilfinger is delivering the entire process control system for the project.

The system will be designed, built and programmed in Germany. Following testing and customer acceptance, it will be shipped to Iran. The order has a volume of several million euros, though the parties agreed not to disclose the exact amount. The contract was signed during a visit of the Iranian delegation to Bilfinger headquarters in Mannheim.

"Our engineering services made in Germany are an international seal of quality. I am delighted that we will be able to contribute our quality and reliability to the ambitious project in Iran", says Tom Blades, CEO at Bilfinger SE. "Iran has a great deal of pent up demand when it comes to the modernization of its industrial facilities and Bilfinger can make a contribution here in cooperation with Iranian companies."

The refinery in the city of Esfahan is operated by the Esfahan Oil Refining Company (EORC). It went into operation in 1979 and has a processing capacity of up to 370,000 barrels per day. The refinery will be upgraded through the addition of a so-called Diesel Hydro Treatment plant which will be used to produce environmental friendly diesel in accordance with the Euro 5 norm.
