Additionally, Bilfinger will leverage its global pharmaceutical specialists to support the customer's specific requirements. The company will use a Project Delivery Concept (PREDICT) in combination with the customer's best practices to ensure effective stakeholder engagement at all levels. Bilfinger will also deploy

industrial photogrammetry and 3D scanning for project surveys to enable digital design within the built environment, enhancing the stakeholder experience.

The framework agreement covers numerous projects, ranging from laboratory upgrades to new security control rooms. Planning is underway on the first project, an EPCM delivery hub which will house all of the Bilfinger personnel and contractors working on the EPCM projects within a truly collaborative environment, enhancing cultural alignment and continuous improvement.

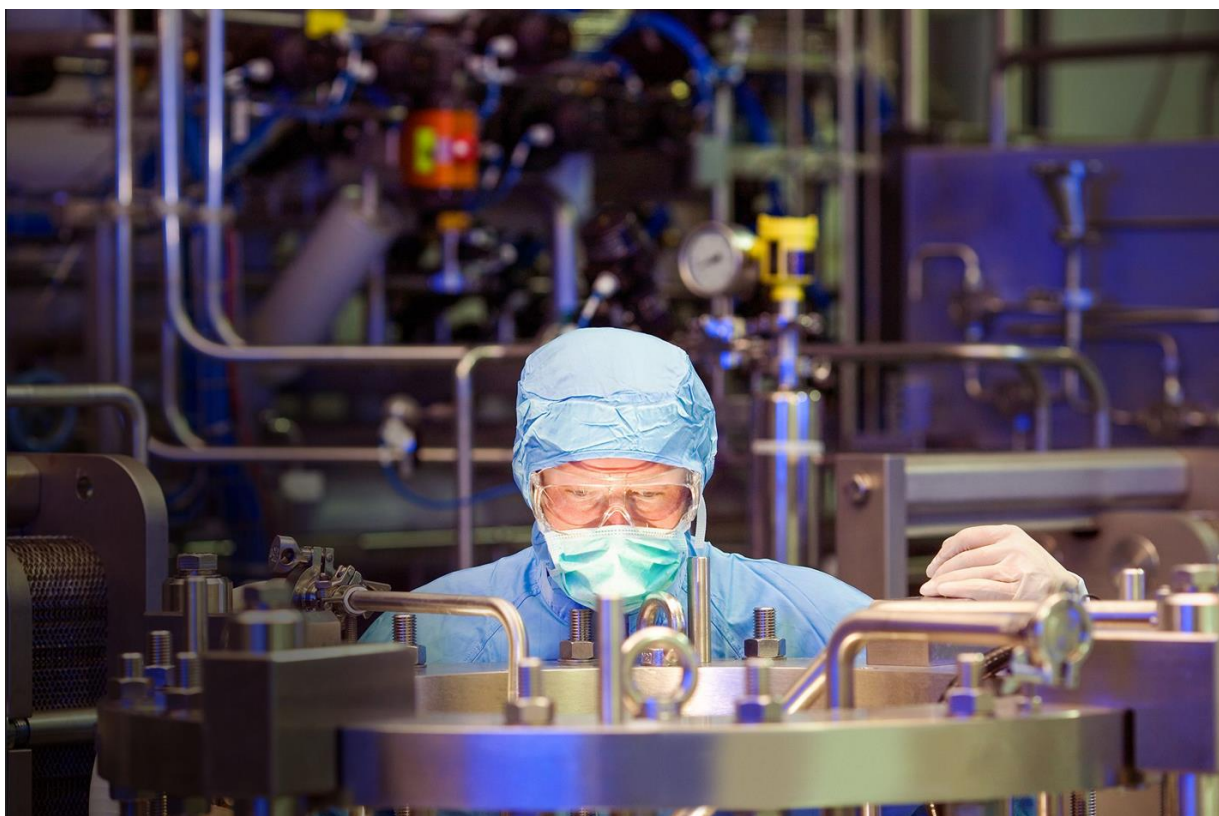
